

## WISCONSIN'S E-CYCLE LAW

Wisconsin's electronics recycling law, 2009 Wisconsin Act 50, covers two categories of electronics, covered electronic devices and eligible electronic devices.

## LANDFILL AND INCINERATION BANS

In addition, the law bans the landfilling and incineration of Eligible Electronic Devices (EEDs), and cell phones as of Sept. 1, 2010. These bans apply no matter where the devices are from or who used them-including households, schools, businesses, governments, and institutions. Specifically, the bans include:

- Televisions.
- Computers (desktop, laptop, netbook and tablet computers).
- Desktop printers (including those that scan, fax and/or copy).
- Computer monitors.
- Other computer accessories. (including keyboards, mice, speakers, external hard drives, and flash drives).
- DVD players, VCRs, and other video players (i.e., DVRs).
- Fax machines.
- Cell phones.

## Day(s)/ Hours: December – January

Saturday: 8:00 a.m. to 3:30 p.m.

## February and March

Second Saturday of each month 8:00 a.m. to 3:30 p.m.

The Facility is **CLOSED** on all observed holidays throughout the year.

## MATERIALS ACCEPTED

### **Yard Waste** (two designated areas)

1. Grass, leaves, garden waste
2. Brush, branches, limbs, logs (10' length limit & 24" diameter max.)

**No stumps, treated wood products or railroad ties accepted.**

**Waste oil/Antifreeze:** Put in plastic container with cap. No container larger than 5 gallons.

**Oil filters:** Drain excess oil out.

## COMMERCIAL USE

**Commercial use of the Residential Yard Waste Facility is prohibited.**

**SEASONAL** Brush pickup is offered once a year (early June), dates and instructions will be advertised in local newspapers as well as on the Village Web Site.

## CURBSIDE RECYCLING (CARTS)

**RECYCLING PICKUP** is every other week on the same day as your garbage pickup.

## MATERIALS ACCEPTED IN CART

**Commingled Recyclables:** No labels need to be removed, but containers should be rinsed clean and placed in the cart.

**Aluminum:** Clean foil and cans

**Bi-Metal Cans**

**Plastic Containers:** All those that have numbers 1-7 within the recycling arrows.

**Glass Containers:** Brown, green, and clear.

**Paper Products:** Newspaper, magazines, office paper, paperboard, hard cover books, telephone books, and corrugated cardboard.

**Miscellaneous:** Large items such as carpeting, linoleum, mattresses, treated wood, furniture, etc. can be brought directly to:

**REMEMBER** to use local charities for household items that are still serviceable. Many offer free pickup of these items. i.e., Good Will, Salvation Army, St. Vincent de Paul, Purple Heart, Habitat for Humanity, etc.



## GARBAGE COLLECTION

**Multi-Family Units:** Garbage collection is contracted independently, and you need to contact your manager/homeowner's association for instructions. Recycling Receptacles are provided. One for commingled products, and one for paper products.

**Residential Garbage:** Pickup is once per week. When there is a holiday between Monday and Friday, the pickup service is pushed one day forward for that week only. **Household Hazardous Waste (HHW):** (Paint, pesticides, etc.) are not accepted. Paint may be dried in its container, soaked up with cat litter, or painted onto cardboard or wood and **only then disposed of in the garbage.** Other HHW should be stored at home for disposal during a "Clean Sweep" program. Washington County residents are also allowed to use the Veolia Household Hazardous Waste Collection Facility at their Port Washington location. Please call 1-800-556-5267 for information and directions. Fees apply. Or contact the **Washington County Clean Sweep** at 262-335-4800 for information on what they will accept.

## ANNUAL BULK PICK-UP

Included in the Village of Germantown's contract with Waste Management is a one-time per year curbside pickup of 2 bulk items per single family residence at no charge to the resident.
