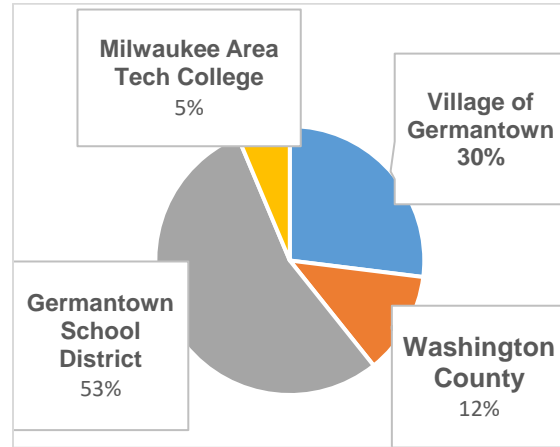


VILLAGE OF GERMANTOWN 2022 PROPERTY TAX

As you view your property tax bill remember that your property tax bill is divided among four taxing jurisdictions: Washington County, Village of Germantown, the Germantown School District, and the Milwaukee Area Technical College. The property tax bill for each individual property is calculated by multiplying the property tax rate by the assessed value for the property, and then adjusting for State tax credits. As you view your bill if you have a question about your assessed value you may call the Village Assessor, Associated Appraisal Consultants, Inc. at 920-749-1995.

The pie chart shows the percentage division of the tax collected for each of the taxing jurisdictions.

BY MAIL:

THROUGH JANUARY 31ST. Use the enclosed envelope or the address below.

This is a lockbox which delivers directly to US Bank.

Checks should be made payable to Village of Germantown. Remember to endorse any escrow check. **The lock box will be closed February 5th**, payments received after that date will be forwarded to Washington County.

Please be aware that the bank lock box does not save envelopes, postmarks cannot be verified, end of year payments will be credited for December 31st only through January 5th if your check is dated 2022.

Payments after February 5th, should be sent to: **Washington County Treasurer, PO Box 1986, West Bend, WI 53095-7986.** (Business Personal Property tax bills should always be sent to Village of Germantown)

IN PERSON:

Germantown Village Hall, N112 W17001 Mequon Road, from 8:00 AM to 4:30 PM, Monday through Friday, through JANUARY 31ST.

EXCEPT the following dates: **CLOSED** - December 23rd, 26th, 30TH & January 2ND.

US BANK:

County Line Road - will accept payments at the branch office at N96 W18480 County Line Rd during their regular business hours and **only through January 31**. This is a Payment Location only, questions on your bill should be directed to Village Hall.

ONLINE:

Pay taxes online, through January 31, 2023, on the Village website.

All fees are the responsibility of the taxpayer. The Village does not receive any portion of the fee.

E-Check: \$1.50 up to \$10,000 or \$10.00 for amounts over \$10,000

Credit/Debit Card: **2.39%** of the payment amount (minimum fee \$1.50) VISA, Mastercard, Discover

DROP BOX:

Through January 31st – To the Right of the front door of Village Hall, (Door under the Clock Tower)

Payments will be credited on the date received by Village staff. Refund checks will be mailed separately and may take up to three weeks. The Village does not mail payment receipts.

DOG AND CAT LICENSE APPLICATION

Village Ordinances require all dogs and cats in the Village to be licensed annually, by March 31. Please complete the application, and mail it to the **Village of Germantown, PO Box 337 Germantown WI 53022**. Your license will be returned to you by mail. **It is required that your license show the pet's rabies vaccination number and expiration date.**

The Village of Germantown ordinance provides that any premise on which any person keeps more than three dogs or three cats or a combination thereof over the age of five months needs an Animal Fancier License. To receive an Animal Fancier's License, an application and fee are filed with the Clerk.

This is a separate application that is available on the Village Website and at the Clerk's Department. The annual application process includes Public Safety Committee approval and possibly Village Board approval prior to issuance. The annual cat and dog license would still apply.

2023 Updates to Make Note Of: (from our DPW Department)

Starting in 2023 the Village will no longer be picking up brush in May and October. Moving forward, there will be a **SINGLE** annual brush pick-up that will take place in early June. The change accommodates ****buckthorn**** collection when the plant is least likely to contain berries which spread the invasive plant throughout the Village.
